- Current resume.
- 3 Letters of reference (one of the three letters must be from current or former teacher/instructor/professor)
- Student essay about why you want to be a paralegal including the importance of character and credibility AND demonstrating your leadership and extracurricular/community involvement (Limited to 2 pages or 1,500 words or less)
- Letter of acceptance from the educational paralegal program director.
- Certified copy of high school (GED equivalent) or college diploma and any paralegal program transcripts.

### RESTRICTIONS

- At its sole discretion, the SDPA Scholarship Committee will annually disburse one scholarship of \$500 to a student from one of the following schools: Cuyamaca College, Miramar College, Southwestern College, UCSD or USD.
- Nonrenewable.
- Scholarship must be applied towards tuition and/or school materials related to paralegal studies.
- High school diploma or GED required. College degree not required.
- Must be currently enrolled and attending full- or part-time in paralegal program at Cuyamaca College, Miramar College, Southwestern College, UCSD or USD at the time of the scholarship application.
- Current San Diego Paralegal Association members and non-members are encouraged to apply.
